

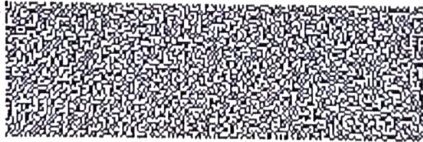

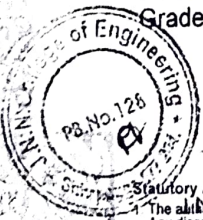

2. OBJECTIVES OF THE MOU:

On mutually agreed terms & conditions and availability of expertise & resources the following items can be carried out for the mutual benefits of JNNCE-MBA and GFGC, N.R.Pura with the concerned institution/ resource persons from time to time.

- a. **Joint Workshops / Seminars:** The parties agree to organize / conduct, whenever feasible, joint seminars / workshops / conferences in the identified areas for the benefit of the students and faculty members of JNNCE-MBA and GFGC, N.R.Pura
- b. **Consultancy:** For specific technical problems, GFGC, N.R.Pura can approach JNNCE-MBA based on expertise, equipment and experience and on mutually agreed terms & conditions the same will be carried out.
- c. **International Relations:** JNNCE-MBA can leverage the knowledge of their collaborating partners from the reputed universities in USA, Europe, Asia, etc. for any works identified by GFGC, N.R.Pura
- d. **Executive Development Program / Training:** JNNCE-MBA can provide training to GFGC, N.R.Pura Students/Staff in the identified areas of work or specialization.
- e. **Joint Publication of Papers:** The parties will use the results for academic publications jointly. The authorship of the potential publications will be shared between the parties.
- f. **Research Projects:** JNNCE-MBA shall solely or jointly undertake research projects with GFGC, N.R.Pura in the identified areas on mutually agreed terms & conditions. Both the organizations shall also submit collaborative research projects to various national and international funding agencies. In collaborative research both the institutes would ensure the successful completion of the funded research projects. For all the matters concerned, a co-ordination committee overseeing the issues consisting of five members (Two members from JNNCE, three members from GFGC, N.R.Pura) for identifying joint research projects to be carried out under this MoU. The ethical approval of these projects if any would be granted by Ethics Sub Committee of JNNCE-MBA.

The details for the efficacious implementation of this Memorandum of Understanding shall be jointly worked out on mutually acceptable terms within the parameters of the policies, rules and regulations of both the institutions

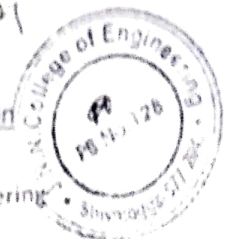

This MoU or any part thereof may be amended at any time during its tenure only by the consent, in writing, of the parties concerned.
